

2024 Priority Pass one-year membership acquisition offer - Terms and Conditions

- 1) The 2024 Priority Pass one-year membership acquisition offer (the "Offer") is from 1 January 2024 to 31 December 2024 (both dates inclusive) (the "Promotional Period") and shall at all times be subject to these terms and conditions ("Terms and Conditions").
- 2) The Offer is applicable to selected customers of The Hongkong and Shanghai Banking Corporation Limited (and its successors and assigns) ("HSBC" or the "Bank") in the Hong Kong Special Administrative Region ("Hong Kong") who have fulfilled the following requirements (the "Eligible Customers"):
 - (a) Be aged 18 or above on 1 January 2024; AND
 - (b) not be a citizen of the United States of America ("U.S."), a U.S. resident, and/or a U.S. tax payer resident
